## Key dates

May 12 – 19, 2020

There will be a brief period during which you can't make changes to contributions, but you can still access your account, request fund transfers, update your beneficiary or review investment performance.

### Starting May 20, 2020:

Log in to your account at [TIAA.org/udayton](https://TIAA.org/udayton) and locate the link to change your contribution under the *ACTIONS* header.

Follow the prompts to start or make changes to your contributions.

Starting May 20, 2020:
