Instructor Instructions

The Common Academic Program requires all undergraduates to complete a capstone course or experience. One mandate of the capstone is for you to demonstrate an advanced understanding of your chosen vocation.

The University of Dayton's definition of vocation expands on the common use of the term -- a strong desire to spend your life doing a certain kind of work (Merriam-Webster). The University of Dayton's definition of vocation is:

Using appropriate scholarly and communal resources, all undergraduates will develop and demonstrate ability to articulate reflectively the purposes of their life and proposed work through the language of vocation. In collaboration with the university community, students' developing vocational plans will exhibit appreciation of the fullness of human life, including its intellectual, ethical, spiritual, aesthetic, social, emotional, and bodily dimensions, and will examine both the interdependence of self and community and the responsibility to live in service of others.

To demonstrate students' advanced understanding of how psychology has influenced their vocation, students will—at the instructor's discretion—either write a paper (the body of which should be between two and five pages, double-spaced) or create another project that speaks of their appreciation for the fullness of the intellectual, ethical, spiritual, aesthetic, social, emotional and bodily dimensions of their life, the interdependence of themselves and community and their responsibility to live in service to others.

In creating the vocational project, students should reflect on the following questions:

1. How will your knowledge of psychology and psychological phenomena propel your career trajectory?
2. In the short- and long-term future, how has your knowledge base created by majoring in psychology and/or common academic program coursework and other University of Dayton coursework influenced your ability to contribute to [the greater good in/of] society?

Scoring Rubric:

0 = absent 1 = developing 2= satisfactory 3 = outstanding

Scoring:

Student did not successfully complete either of the rubric objectives listed above = 0

Student satisfactorily completed one of the two rubric objectives listed above = 1

Student satisfactorily completed both rubric objectives listed above = 2

Student's completion of each rubric objective was outstanding = 3
